Students will take specific coursework on food and nutrition, physical environment and safety, marketing and public relations, and financial management for long-term care. Students will also study concepts in leadership, gerontology, ethics, and death and dying. Students learn about the legislative process and Medicare and Medicaid fundamentals, Nursing Facility Standard – the State Operations, including the Long Term Care Survey process.	\$31.05 per hour; \$64,584 annually. Our Long Term Care Administration program allows you to choose the career pathway that best fits you. Whether that's leading a team in assisted living or working within nursing home administration office, this program provides the skills you'll need. As an administrator, you are the chief executive responsible for planning, organizing, leading, and supervising the operations of a home for the aged licensed by Health and Human Services.

Based on the state in which you plan to begin your career, you will need to complete an administrator-in-training program in addition to your degree.

SCC is offering an LTCA practicum course to assist you with the administrator-in-training process. A criminal background check will need to be complete prior to enrolling in the practicum. During the practicum class you are eligible to take the National Association of Long Term Care Administrator Boards.

This may vary from state to state.

Our Long Term Care Administration courses can also count as continuing education hours if you already hold your Nursing Home Administrator license. Contact us for more information.
